In 2017 the 16 Years, 18 Years and Opens QLD Cup Team/s may also be the teams that compete in the QLD Premier League. that will mean that players will be required to play in the Chosen Premier competition by the SCNA Executive on a weekly basis along with chosen Carnivals. Final decision of team naming is at the discretion of the SCNA Executive.

NON-REFUNDABLE NOMINATION FEE \$20 PAYABLE WITH NOMINATION FOR ALL AGES.

Important notes to consider prior to trialling:

- Players selected into Representative quads, will be required to pay a \$100 non-refundable deposit within 1 weeks of selection. Failure to pay will result in the position in the team being offered to another player.
- Players named in the 12 years, 13 years, 14 years, 15 years squads are also required to attend Player Development Program, dates have been confirmed as the 08/02/2017, 15/02/2017, 22/02/2017
- Players will be trialling for **either A or B Team** for their respective age group; players cannot select the team they wish to trial for.
- Any player who withdraws from the chosen Representative Team after team announcements will not be eligible to trial and play for a Representative Team the following year and will not be refunded the \$100 deposit.
- Further information regarding location of State Carnivals will be provided to all at trials or when details become available.
- Any player who cannot trial must complete nomination form and write to the Rep Convenor with reason/s why unable to trial along with any additional documentation supporting your reasons.
- Any player trialling for Representative (State Events) and Queensland Premier League please note that you possibly will required to train 2 times a week, commit to carnivals and commit weekly Premier League games.
- **All players required to commit to the entire Representative/Premier season as per the dates of State Events and Queensland Premier League.**
- **All Players** are to read and agree to the SCNA Representative Player Policy and must agree to this
